

Stockholders who intend to attend and participate in the meeting by remote communication must notify the Company by email at [asm2026@ipeople.com.ph](mailto:asm2026@ipeople.com.ph) on or before **July 21, 2026**. The link to the live webcast of the meeting and the proxy form shall be sent to the email address of the registered stockholder.

For voting via proxy, duly accomplished proxies shall be submitted by email to the Office of the Corporate Secretary at [asm2026@ipeople.com.ph](mailto:asm2026@ipeople.com.ph), for examination, validation, and recording no later than 5:00 pm of **July 21, 2026**. Proxies received thereafter shall not be recognized for the meeting. The validation of ballots and proxies shall be held on July 23, 2026, 2:00 PM, at iPeople inc.'s office at the 8/F Mapua University Makati Campus, 1191 Pablo Ocampo Sr. Extension, Makati City.
